2. Approval of the November 29, 2007 Minutes

3. **NSI Update**

Ms. Valerie Carrigan distributed a program summary of the Next Skills Institute. October 19 was the marketing roll out event. SETA is one of the sponsors and NSI is looking for funding for future trainings. This program can be run through the Employment Training Panel (ETP). Ms. Carrigan distributed copies of the certificates received by participants that attended, participated, and completed the NSI class. SETA has agreed to sponsor the SAHRA SWELL awards. This is available for other organizations to utilize.

4. Report back on Career Builder

Ms. Carpenter reported that the Committee looked at Employon and CareerBuilder; she looked at Yahoo Hot Jobs as well. The Committee gave her the 'green light' to go with CareerBuilder if the price would be for \$10,000; Ms. Carpenter negotiated a price of \$9,999. The Partnership includes five postings a month on CareerBuilder site; she reviewed the things included in the agreement with CareerBuilder. Ms. Carpenter stated that staff will be double entering jobs into both Cal Jobs and CareerBuilder. Ms. Ferrari is working to set up a meeting with a Cal Jobs person to get this worked out. Our CareerBuilder link is set up and will officially launch by February 1.

5. Second Quarter Employer Outreach Report

Ms. Carpenter distributed the report which indicates less hiring going on. Last year we got 250 hires out of the Franchise Tax Board. The average wage is down by 4%.

Ms. Hayes stated that she, Ms. Purdy and George Hempe will be meeting with ETP about two green energy training programs. A training curriculum for solar panel installers, inspectors and public works people that do permitting for solar energy is being developed. There is a growing need for people that can work on solar panels.

A second pot of ETP funds would be for entrepreneurial development for green/clean energy.
