2. Approval of the February 28, 2008 Minutes

Moved/Pardun, second/Mahood, to approve minutes as distributed. Voice Vote: Unanimous approval.

### 4. Information Item: Employer Outreach 2007-2008 Budget

Ms. Carpenter distributed information on the 2007-2008 budget. The budget is close to being entirely spent. The Fifth Annual Employment and Training Expo will be moved to September due to the increased activity in coordinating youth job fairs this spring. The idea is to center the event around Labor Day in order to gear up for holiday hiring. The September event will also focus on "Hire a Vet".

Ms. Carpenter spoke of the movie ads that ran for five weeks during the holiday season. Next month the Committee will be going over the proposed 2008-2009 Employer Outreach budget and will be discussing marketing ideas for 2008-2009.

Ms. Smith-Dohring inquired whether the number of jobs for youth has increased. It was suggested the youth be provided more information about what they need to do/study to get a job or career.

Ms. Carpenter stated that an e-mail blast will be sent to employers with link to the web site so employers can access the updated web site.

### 3. Information Item: Prison-to-Employment Pilot Project

Mr. Walker stated that thirty-six attendees showed up at the Sacramento Works Employer Forum. He reviewed some of the areas of concern with the employers. Mr. Walker spoke of the New Start Program where parolees enter training or fire camp. Of the 100 people paroled, three to five parolees receive training in prison. There are efforts to increase the number of vocational training programs in prison.

The Parole And Corrections Team (PACT) is a mandatory workshop for exoffenders paroling to Sacramento County. Ms. Purdy stated that SETA is one of six counties to test out new ways to assist parolees transitioning to work. Staff is negotiating with the State for money to operate the program and fund two more staff members. Staff is hoping to receive \$250,000 for the program.

Ms. Purdy stated that Warren Murphy, Juanita Sendejas Lopez, and Mary Garza are working on the PACT workshops. Staff is already providing the new services to ex-offenders; staff just needs to figure out which partner will provide which service.

Mr. Mahood suggested having employers and/or committee members attending the PACT meetings.

Mr. Walker stated that staff will be meeting on how to deal with female exoffenders. The hope is that staff can connect with the ex-offenders to get them into the career centers for employment services.
