I. Meeting to Order/Roll Call: Ms. Kim Parker called the meeting to order at 9:50 a.m.

2. Approval of the November 19, 2008 Minutes

Moved/Ingram, second/Pardun, to approve the November 19, 2008 minutes. Voice Vote: Unanimous approval.

6. <u>Update:</u> Clean Energy Technology Employer Roundtables

Ms. Kossick reviewed the information on the Roundtables. Ms. Hayes stated that she will be attending all of them. The invitations were just sent out two weeks ago

Ms. Hayes reported that there is a list of 45 identified clean tech companies which means they have to be involved in research, development and marketing of clean energy products. These 45 companies were invited as well as 70 companies that do solutions (installation/repair). It is hoped that 45 people will be at the roundtables. Approximately 30-40 came to the last roundtables; a report was developed with action items.

3. <u>Update</u>: Review of Sacramento Works DVD Distribution Plan

Ms. Carpenter stated that it was discussed at the November Employer Outreach meeting that the Sacramento Works DVD that promotes our career centers would also be a great marketing tool for employers. In consulting with Circle Point, the issue was raised that when people get DVDs, do they trash them? If cost was invested to direct mail the Sacramento Works DVD--How many would be played or how many would be discarded? EMRL proposed doing a small mailing (500 or less) of the DVD. First, send out an e-mail notifying the employers they will receive it and then do a follow-up call. Tell the employers

that we are here for you is there anything we can do for you? Approximately 1,000 DVDs will be ordered because we get a price break. Ms. Carpenter is still working on this but wants to make sure it is cost effective. The other 500 will be hand delivered to employers or distributed at employer focused events like Biz Expo. Mr. Ingram suggested that we work SAHRA and distribute the DVD at each seat at their regular monthly luncheon with Kim Parker, Workforce Investment Board VP providing a short intro about employer services and referencing the DVD at their table.

4. Update: Employer Outreach Radio Advertising Plan

Ms. Carpenter evaluated the various radio proposals from a variety of radio stations. After discussing the proposals with several board members, it was decided to go with KFBK. Ms. Carpenter was able to negotiate a really good price. The radio ads begin in May. The 30-second spots will be run more frequently within a two week period. The rate has been locked in and can be extended to other months as well. Ms. Carpenter is working closely with EMRL and looking at doing something new for the radio ad; perhaps a documentary telling employers of how they worked with Sacramento Works Additional information will be brought forward to the committee in March.

Ms Smith-Dohring suggested putting the ads on You Tube or Facebook. Ms. Carpenter stated that the Sacramento Works television ads as well as, the Sacramento Works DVD were already posted on You Tube.

5. Update: Employer Outreach Budget through 12/31/08

Ms. Carpenter reviewed the report and stated that we are now at 50% of budget. She spoke of participating in the BIA Safety Expo which will be a new opportunity to market ourselves. We scrapped the Channel 10 idea because we have way too many job seekers; we need more employers.

Mr. Ingram reported that an employer roundtable was held at SETA and it was a conversation about the challenges a newly released prisoner faces and the stigma of ex-offenders coming into the work place. California is woefully behind in programs to assist ex-offenders. Employers are needed right now. Ms. Ferrari reported that she has assigned two staff to assist in this program.

If ex-offenders can stay out of prison for 90 days, there is a pretty good likelihood that they will remain out of prison.

Mr. Pardun stated that there are three Enterprise Zones. He has been working with Bill Walker on this and offered to give a report on how this relates to job creation. The Enterprise Zone area is expanding dramatically.
