RESEARCH ON THE INFORMATION AND COMMUNICATIONS TECHNOLOGIES (ICT) SECTOR

BACKGROUND:

On March 23, 2010, Sacramento Works, Inc. allocated Board Initiative funds in the amount of \$20,000 to the Los Rios Center of Excellence to conduct labor market research on the Information and Communications Technologies (ICT) sector.

This occupational sector is related to computer networking and telecommunications, is new and emerging and has job functions associated with related sector occupations impacting all businesses, regardless of industry type or number of employees.

The Los Rios Center of Excellence, the Golden Sierra Workforce Investment Board, and SETA/Sacramento Works, Inc. contributed funding to the study. The findings of the study will be used to train the staff and partners at the Sacramento Works One Stop Career Centers on the types of emerging occupations, the skills, competencies and certifications required to successfully compete for jobs in this sector, and to assist training providers develop appropriate curriculum to teach the necessary skills.

Theresa Milan, Director of the Center of Excellence will present the findings of the study.

Board members were asked to contact Ms. Kossick or Ms. Parker regarding their availability to make a presentation at the March meeting.

→ Presentation: Suzanne Mayes, Valley Vision: Report out on the Clean Tech Energy CEO Roundtable Results: Ms. Mayes thanked some of the sponsors Los Rios, Seta and Bank of America. Ms. Mayes reported that access to capital continues to be a challenge. Companies are hiring primarily in sales, procurement and administrative positions. Biomass has great potential for investment and job creation. Jobs will increase in waste haulers and truck drivers. Programs need do to a better job tracking data and publicizing outcomes. Ms. Mayes stated that the next steps include: share and review findings, identify focus areas for GCA and its partners, secure project funding, and implement actions with support.

Mr. Camp stated that there are significant employment opportunities if there is coordination with regional programs.

Mr. Younger stated that the cost of power in Europe is much higher so it pays to put money into the solar panel infrastructure; it is not really cost effective in the United States.

III. Discussion/Action Items

A. Review and Approval of the Request for Proposals for WIA Youth Program Services for the Fiscal Year Beginning July 1, 2011

Ms. Christine Welsch stated that this is the first time in four years to do procurement for the year-round youth program. There were guest speakers at Youth Council meetings to discuss issues pertinent to youth. This document will be reviewed by the SETA Governing Board. Once approved, the RFP will be released and a bidders' conference is scheduled for February 17. Services will begin July 1.

The Youth Council believes in three tenants: personal responsibility, youth involvement, and collaboration. The program requires that the youth providers collaborate with a career center and a local community based organization. Youth specialists at the career centers are required to do outreach to the local schools. The youth advocates are young people and must work specifically with youth. Extra points are given to providers that incorporate WIA service learning, green jobs strategies, career pathways, and high risk youth. Providers are being encouraged to make changes in their service design. Staff is expecting the same allocation as last year, \$2.8 million, but the exact amount will not be known until later.

Moved/Camp, second/Portela, to approve the Request for Proposals for the WIA Youth Program Services for the Fiscal Year beginning July 1, 2011. Voice Vote: Unanimous approval.

B. Approval of the 2010-11 Workforce Investment Area Plan Summary

Ms. Purdy reviewed the compilation of services that have occurred over the past year. Staff will be coming back in March with the board's strategic plan.

There has been significant job growth in manufacturing, construction, financial services, education and health services sectors in 2011. Staff will continue to focus on critical occupational clusters and continue to focus on sector initiatives, especially green initiatives and health care initiatives.

Continue to focus on programs that work with at-risk adults. The Department of Human Assistance has provided \$3.7 million in one-stop share of costs for one stop services over the last year, which assists to increase activities offered at the one stops.

Ms. Purdy reviewed the changes in the one stop delivery system. Staff is recommending to increase the percentage of wage subsidies up to 90% and the implementation of jobs. Sacramentoworks.org, which is a virtual one stop career center available to everyone. This is a very powerful system which will revolutionize the one stop career system.

Ms. Botos left at 9:12 a.m.

Ms. Purdy reported that 19,000 customers received staff assisted services, and of the 19,000, 10,750 completed services and 4,338 were employed which shows a 40% employment rate. This is low because the goal was 48%. It is recommended to increase the amount of money going into OJT because it has a better return; more people go to work.

Adults are more comfortable going into a career center without staff assistance. Youth specialists are available to assist youth in their job search.

Staff is in the process of following up on customers that went through ARRA training. Staff found that for occupational skills training, there was a really fast startup and 12-15 providers were funded. However, the recruitment was not done through the career centers. Staff found that there was not a sense of engagement with the career centers. In the resource allocation plan, staff is recommending moving funds into OJT to provide an incentive to employers to hire people.

<u>UPDATE ON SACRAMENTO WORKS STRATEGIC PLAN</u> GOALS, STRATEGIES, OUTPUTS AND OUTCOMES

BACKGROUND:

At the Sacramento Works, Inc. Board Retreat in 2009, the board began a strategic planning process that resulted in the creation of three strategic goals:

- 1. Support regional employers' efforts to hire, train and transition employees by enhancing and communicating the availability and value of Sacramento Works' employer and business services.
- 2. Prepare customers for viable employment opportunities and career pathways in the region by improving the One Stop Career Center system.
- 3. Prepare youth to thrive and succeed in the regional workforce by providing relevant work readiness and employment programs and engaging regional employers and academia.

Each of the Sacramento Work's, Inc. Committees (Employer Outreach, Planning/ Oversight, and Youth Council) has reviewed and approved the goal, strategies, planned activities, outputs and outcomes developed by their committees. The summary of the plan and achievements will be sent under separate cover.

ITEM III-B - ACTION

APPROVAL TO SUPPORT AND PARTICIPATE IN REGIONAL PROPOSALS TO THE U.S. DEPARTMENT OF LABOR

BACKGROUND:

The U.S. Department of Labor (DOL or the Department), Employment and Training Administration (ETA) has announced the availability of three Requests for Proposal for Federal Grants. Each of these grants requires support or coordination from local Workforce Investment Boards. Staff has been contacted by several providers requesting that Sacramento Works, Inc. participate in and support their proposals.

Green Jobs Innovation Fund (GJIF)

US DOL has announced that approximately \$40 million in grant funds authorized by the Workforce Investment Act of 1998 will be used for the Green Jobs Innovation Fund (GJIF). The GJIF will increase the number of individuals completing training programs who receive industry-recognized credentials and will increase the number of individuals completing training programs for employment in green jobs. DOL intends to fund approximately five to eight grants to national and statewide organizations with local affiliates with existing career training programs to provide technical and basic skills training that lead to green job opportunities in at least six communities per grant. Applicants are eligible under one of three categories: 1) national labor-management organizations with local affiliates; 2) national non-profit entities with local affiliates; or 3) statewide non-profit organizations or state Workforce Investment Act administering agencies with local affiliates. The purpose of these grants is to develop green career pathways by: 1) forging linkages between Registered Apprenticeship and preapprenticeship programs, and/or 2) integrating the delivery of technical and basic skills training through community-based partnerships.

Proposals are being submitted by:

- A collaboration which includes the California Labor Federation, Employment Development Department, California Workforce Investment Board and the California State Building & Construction Trades Council
- Home Builders Institute (HBI), the 501(3)c affiliate of the National Association of Home Builders (NAHB), with local partner North State Building Industry Association

Career Pathways Innovation Fund (CPIF)

U.S. Department of Labor also announces the availability of up to \$122 million in grant funds to be awarded under the Career Pathways Innovation Fund (CPIF) Solicitation for Grant Applications. DOL intends to fund approximately 40 to 50 grants ranging from \$1 million to \$5 million. The grants awarded under this Solicitation will support successful applicants in developing and implementing career pathway programs in partnership with

employers and other relevant organizations in the community. The overarching goals are to: 1) increase the number of individuals who earn credentials that enable them to compete for employment in in-demand and emerging industries and occupations; 2) lead to employment for program participants; 3) articulate and ease academic and employment transitions; 4) establish multiple entry and exit points for students along the post-secondary education continuum; and, 5) create systemic change.

Proposals are being submitted by:

- 1. The Los Rios Community College District, in partnership with Yuba Community College District, Sierra College, Lake Tahoe Community College, and Butte College and the five Workforce Investment Boards in Northern California.
- 2. California State University, Sacramento in partnership with Sacramento Works, Los Rios Community College District, SEIU, Sacramento City Unified School District, and the California Teachers Association.

Enhanced Transitional Jobs Program (ETJ)

- U.S. DOL announced the availability of approximately \$40 million in grant funds to support successful applicants in providing enhanced transitional jobs (ETJ) programs, as well as other activities and services, to increase the workforce participation of low-income, hard-to-employ populations, specifically non-custodial parents and/or exoffenders reentering their communities.
- Sacramento Employment and Training Agency/Sacramento Works Inc. will submit on behalf of a partnership including Elk Grove Unified School District, Asian Resources, Inc., Greater Sacramento Urban League, Sacramento County Probation Department, California Department of Corrections, Sacramento County Office of Education, and Sacramento City Unified School District.

Summaries of the proposals will be presented to the board at the March meeting.

SACRAMENTO-ARDEN-ARCADE-ROSEVILLE METROPOLITAN STATISTICAL AREA (MSA) (EL DORADO, PLACER, SACRAMENTO, AND YOLO COUNTIES) Seasonal declines lead month-over job loss

<u>NOTE</u>: Labor Force and Industry data contained in this release differ from previous information due to the U.S. Department of Labor's annual revision process.

The unemployment rate in the Sacramento-Arden Arcade-Roseville MSA was 12.9 percent in January 2011, up from a revised 12.6 percent in December 2010, and below the year-ago estimate of 13.0 percent. This compares with an unadjusted unemployment rate of 12.7 percent for California and 9.8 percent for the nation during the same period. The unemployment rate was 12.9 percent in El Dorado County, 11.6 percent in Placer County, 12.9 percent in Sacramento County, and 15.3 percent in Yolo County.

Between December 2010 and January 2011, the total number of jobs located in the counties of El Dorado, Placer, Sacramento, and Yolo decreased by 12,600 to total 797,800 jobs.

- Trade, transportation, and utilities fell 4,300 jobs with seasonal losses in retail trade (down 3,000 jobs), transportation, warehousing, and utilities (down 1,100 jobs), and wholesale trade (down 200 jobs).
- Construction receded by 2,200 jobs which compares to an average loss of 3,000 jobs over the prior 20 years. Specialty trade contractors fell 1,300 jobs followed by residual construction (down 700 jobs), and construction of buildings (down 200 jobs).
- Government employment decreased by 1,100 jobs, more than the typical 20-year average loss of 800 jobs. Declines in local government (down 1,400 jobs) and federal government (down 100 jobs) were partially offset by increases in state government (up 400 jobs).

Between January 2010 and January 2011, total wage and salary employment in the region dropped by 13,600 jobs or 1.68 percent.

- Government employment contracted by 5,400 jobs due to cutbacks in local government (down 6,000 jobs) and federal government (down 200 jobs). State government gained 800 jobs.
- Financial activities shed 3,600 jobs due primarily to a 3,100-job decrease in finance and insurance, followed by a smaller loss of 500 jobs in real estate, rental, and leasing.
- Construction declined by 3,200 jobs with losses in specialty trade contractors (down 2,200 jobs), construction of buildings (down 500 jobs), and residual construction (down 500 jobs).
- Four industries increased job totals, including total farm (up 900 jobs), professional and business services (up 800 jobs), private education and health services (up 300 jobs), and manufacturing (up 200 jobs).



Methodology:

Monthly city and CDP labor force data are derived by multiplying current estimates of county employment and unemployment by the employment and unemployment shares (ratios) of

each city and CDP at the time of the 2000 Census. Ratios for cities of 25,000 or more persons

were developed from special tabulations based on household population only from the Bureau of

Labor Statistics. For smaller cities and CDP, ratios were calculated from published census data.

City and CDP unrounded employment and unemployment are summed to get the labor force. The unemployment rate is calculated by dividing unemployment by the labor force. Then the labor force, employment, and unemployment are rounded.

This method assumes that the rates of change in employment and unemployment, since 2000, are exactly the same in each city and CDP as at the county level (i.e., that the shares are still accurate). If this assumption is not true for a specific city or CDP, then the estimates for that area may not represent the current economic conditions. Since this assumption is untested, caution should be employed when using these data.
