#### 1. Call to Order/Roll Call

Mr. Rick Wylie called the meeting to order at 4:13 p.m.

#### 2. Approval of Minutes of the May 20, 2019 Meeting

The minutes were reviewed; no questions or corrections.

Moved/Kossick, second/Ferrari, to approve the May 20 minutes.

#### 3. Continued Discussion of Sacramento Works Strategic Plan

Mr. Wylie reviewed the various documents distributed for review. A number of speakers were brought in to assist in focusing our energies. At the May 22, 2019 meeting, the board agreed to focus on the following:

- 1. Reducing the number of unemployed, part-time employed, under employed or hard-to-employ people in the region.
- Increasing the education attainment of people currently employed to allow for upward mobility.
- 3. How are we attracting businesses?

The Executive Committee needs to discuss #1 and have a better idea of what it is and to clarify terms used to define the populations.

Mr. King arrived at 4:17 p.m.

Mr. King stated that the focus of today's meeting is to give staff direction and focus for the first area. The Committee will develop a statement of objective and then lay out what does success look like including how progress is determined.

Mr. King referred to the minutes of the March 27 meeting which state that the Executive Committee would review and frame out measures. There was also discussion of the regional strategic plan.

When referencing the first area of focus, Ms. Clawson asked how do we measure how many part-time people we are reaching? Mr. Kim replied that staff provided information on the customers entering the job centers. Most of the data collected is voluntarily provided. Mr. King asked what proportion of the self-reported part-time employed individuals go on to full-time employment.

Mr. Kim stated that talking about the hard to employ, there are a number of target groups that could be included in the low-skilled category. Mr. Kim suggested perhaps defining the groups and reporting on the percentage served of that particular group. He suggested defining the groups broadly rather than specifically.

Mr. Ellis asked that if the goal is perfectly met, who will be happy about that? Mr. King replied that this is the board giving staff what they are looking to get accomplished. Ms. Kossick stated that the performance data is reported to the Department of Labor.

Mr. King stated that it is important to clearly define our terms and have a specific definition for low skilled, ex-offenders, disabled, and veterans. It would be better to narrow terms now. Mr. Kim stated that there is often talk about reentry of ex-offenders into CalJobs; the reason they are hard to place is they have low skill levels and their soft skills are also lacking.

Ms. Kossick stated that when the economy is bad, there are a lot of people looking for work; when it is good, fewer people are available.

Mr. King stated that he will take notes and ideas from today's meeting and write it out based on objectives and measures and e-mail to the committee in advance of the July Executive Committee meeting.

Committee members suggested beginning the July meeting at 3:30 p.m.

4. <u>Adjournment</u>: Mr. King adjourned the meeting in Ms. Ferrari's honor at 5:14 p.m.
