ITEM III-A – 2 – ACTION

APPROVAL TO ACCEPT FUNDS FROM THE EMPLOYMENT TRAINING PANEL FOR TECHOLOGY TRAINING AND AUTHORIZE THE EXECUTIVE DIRECTOR TO EXECUTE THE SUBGRANT AGREEMENT, MODIFICATION AND OTHER DOCUMENTS REQUIRED BY THE FUNDING SOURCE

BACKGROUND:

From October, 2002 to September, 2008 the Sacramento Employment and Training Agency (SETA) in partnership with Tech Skills has provided training to 1,598 incumbent workers and delivered over \$2.8 million in training funds to the region. SETA has met the training needs of 36 local employers which includes Federal Express, Freight Systems, Intel, TASQ Technology, Western Blue and Schools Financial Credit Union. Training courses focused on basic, intermediate and advanced technology for IT Technicians, IT Security Specialists, Computer Support Specialists, Database Administrators and Help Desk Support Staff.

SETA was recently funded \$627,322 to provide skills training in Advanced Technology, Pharmacy Technician and Medical Billing and Coding training to 113 new hires that will include veterans, ex-offenders and high risk youth for a two-year period.

RECOMMENDATION:

Approve acceptance of funds for the period June 30, 2012 through June 29, 2014 from the Employment Training Panel and authorize the Executive Director to execute the subgrant agreement, modifications and any other documents required by the funding source.

ITEM III-A – 3 – ACTION

APPROVAL TO SUBMIT A PROPOSAL TO THE COMMUNITY CORRECTIONS PARTNERSHIP AND AUTHORIZE THE EXECUTIVE DIRECTOR TO EXECUTE THE AGREEMENT MODIFICATIONS AND OTHER DOCUMENTS REQUIRED BY THE FUNDING SOURCE

BACKGROUND:

The Sacramento Employment and Training Agency has been a member of the Community Corrections Partnership (CCP) since the implementation of Assembly Bill (AB) 109. The principal mission of the CCP is to study the Sacramento County adult criminal justice system in order to develop a public safety realignment plan resulting from the State of California's shift of low-level offenders from the prison system to the local system. During AB 109 implementation phase, much of the focus has been on the County Sheriff and Probation Department's realignments to meet the needs of an increased population of offenders.

In addition to this collaboration, SETA has worked with the California Department of Corrections and Rehabilitation at Folsom State Prison, the Sacramento Sheriff's Department, the Elk Grove Unified School District at the Rio Cosumnes Correctional Facility and the community to develop career pathways for ex-offenders by building occupational and work readiness skills. Our goal was to provide case management, connect re-entry participants to employers through transitional employment opportunities, and eventually place re-entry participants into unsubsidized employment that can led to careers that pay self-sufficient wages enabling them to become productive members of their communities.

Building on our experience, SETA has developed a proposal that will assist with providing access to comprehensive wrap-around services to the AB-109 population. SETA is proposing to provide a holistic approach by providing vocational, employment and supportive services to ex-offenders. The proposed program is a road map for the ex-offender to follow while on their journey to becoming productive and positive members of their communities. The goal of the program is to develop career pathways for ex-offenders by building occupational and work readiness skills, providing support services and case management connecting ex-offenders to employment opportunities, and placing ex-offenders into unsubsidized employment. The number of clients to be served will depend on the number of referrals from any participating AB 109 agency. The organizational capacity to service this population is approximately 125 to 200 per year. While SETA offers career center services at all 11 Sacramento Works Career

Centers, for the purpose of this program, services will be offered at four of the Career Centers:

SETA is requesting **\$612,637** to serve **122** AB 109 referrals, with the capacity to serve more if needed at a cost of \$5,022 per participant.

RECOMMENDATION

Approve the submission of a proposal to the Community Corrections Partnership requesting \$617, 637 to serve 122 AB 109 referrals and, if awarded, authorize the Executive Director to execute the subgrant agreement, modifications and any other documents required by the funding source.

ITEM III- B – 2 - ACTION

APPROVAL TO AUGMENT SOUTH COUNTY SERVICES, INC. IN THE AMOUNT OF \$89,314 IN COMMUNITY SERVICES BLOCK GRANT (CSBG) FUNDING

BACKGROUND:

South County Services, Inc. (SCS) has been the only comprehensive service provider for low-income and vulnerable families in south Sacramento County for 35 years. Its service area includes the cities of Galt, Elk Grove, Walnut Grove, Hood, Franklin, Isleton, Locke and Ryde. It provides approximately 28,000 safety-net services to residents of these communities each year.

SCS has been a SETA CSBG service provider since the mid-1980s. Funding levels have ranged from \$20,000 to its current \$65,000. SCS has struggled financially in the past two years when funding from the County Department of Human Assistance (DHA) ended. It currently operates on a modified schedule and with reduced staffing.

On June 15, 2010, the Sacramento County Board of Supervisors approved a request by DHA to execute an agreement with SETA that would continue DHA's share of cost of the One-Stop System in the amount \$3,700,000 per year, for up to three years, and continue services to CalWORKs recipients through PY2012-2013. The agreement included a provision to fund SCS to provide services in the rural South County to ensure the continuation of basic emergency services for the underserved Galt and River Delta communities

In August, 2010, the SETA Governing Board approved an augmentation of \$188,000 for SCS with CSBG funding made available through a One-Stop Share of Cost Agreement with DHA, and in July, 2011, approved an additional augmentation of \$60,000 with County of Sacramento funding to ensure continuation of services to the Galt and River Delta communities through the 2011 program year.

SCS's current funding level of \$65,000 in CSBG funding is insufficient for it to remain operational after June 30, 2012. Staff has identified additional funding that will permit continuation of SCS programs and services. Board approval is requested to augment the SCS 2012 CSBG subcontract for \$89,314, which is made available through the One Stop Share of Cost Agreement, to continue the provision of safety-net services from July 1, 2012 through December 31, 2012.

RECOMMENDATION:

Approve the augmentation of \$89,314 in Community Services Block Grant funding for South County Services Inc. to continue the provision of safety-net services in South Sacramento County from July 1, 2012 through December 31, 2012.

UNEMPLOYMENT UPDATE/PRESS RELEASE FROM THE EMPLOYMENT DEVELOPMENT DEPARTMENT

BACKGROUND:

The unemployment rate for Sacramento County for the month June was 10.8%.

Attached is a copy of a press release from the Employment Development Department breaking down the job losses and job creations for the regional area.

SACRAMENTO-ARDEN-ARCADE-ROSEVILLE METROPOLITAN STATISTICAL AREA (MSA) (EL DORADO, PLACER, SACRAMENTO, AND YOLO COUNTIES) Construction led month-over job gains

The unemployment rate in the Sacramento-Arden Arcade-Roseville MSA was 10.8 percent in June 2012, up from a revised 10.4 percent in May 2012, and below the year-ago estimate of 12.2 percent. This compares with an unadjusted unemployment rate of 10.7 percent for California and 8.4 percent for the nation during the same period. The unemployment rate was 10.5 percent in El Dorado County, 10.0 percent in Placer County, 11.1 percent in Sacramento County, and 10.8 percent in Yolo County.

Between May 2012 and June 2012, total wage and salary employment located in the counties of El Dorado, Placer, Sacramento, and Yolo increased by 9,400 to total 827,400 jobs.

- Construction increased by 4,800 jobs, above its average 1,500-job gain from May to June over the last 22 years. Specialty trade contractors (up 2,700 jobs) and construction of buildings (up 1,100 jobs) accounted for a majority of the increase.
- Leisure and hospitality added 2,500 jobs. Accommodation and food services (up 1,900 jobs) and arts, entertainment, and recreation (up 600 jobs) accounted for the increase.
- Trade, transportation, and utilities expanded by 1,800 jobs. Retail trade (up 1,300 jobs) accounted for most of the job gain.
- On the downside, education and health services decreased by 1,600 jobs. Education services and health care and social assistance each lost 800 jobs.

Between June 2011 and June 2012, the total number of jobs located in the region increased by 11,000 or 1.35 percent.

- Education and health services added 4,000 jobs. Health care and social assistance (up 3,600 jobs) accounted for the majority of the increase.
- Trade, transportation, and utilities increased by 2,600 jobs. Retail trade (up 3,000 jobs) and wholesale trade (up 100 jobs) offset a loss in transportation, warehousing, and utilities (down 500 jobs) to account for the increase.
- Professional and business services boosted payrolls by 2,000 jobs. Administrative and support and waste management and remediation services (up 2,100 jobs) offset a loss in professional, scientific, and technical services (down 100 jobs). Management of companies and enterprises remained unchanged.
- Construction also expanded by 2,000 jobs. Construction of buildings (up 1,900 jobs) and specialty trade contractors (up 800 jobs) offset a 700-job loss in the remainder of the sector.
- On the downside, manufacturing and government each lost 700 jobs.







IMMEDIATE RELEASE SACRAMENTO-ARDEN ARCADE-ROSEVILLE METROPOLITAN STATISTICAL AREA (MSA) (El Dorado, Placer, Sacramento, and Yolo Counties)

The unemployment rate in the Sacramento-Arden Arcade-Roseville MSA was 10.8 percent in June 2012, up from a revised 10.4 percent in May 2012, and below the year-ago estimate of 12.2 percent. This compares with an unadjusted unemployment rate of 10.7 percent for California and 8.4 percent for the nation during the same period. The unemployment rate was 10.5 percent in El Dorado County, 10.0 percent in Placer County, 11.1 percent in Sacramento County, and 10.8 percent in Yolo County.

Need to continue increasing the non-federal share. SETA has submitted a waiver to the Office of Head start to waive some of the non-federal share which will ease the burden of the non-federal share requirement. A lot of the additional spending for Head Start is done in the latter part of the year.

V. <u>Committee Reports</u>

- A. Executive Committee: Ms. St. Mary reviewed the critique of the last board meeting.
- B. PC/PAC Joint Executive Committee Report: Ms. Amber Taylor reviewed the critique of the joint PC/PAC Executive Committee. Ms. Taylor spoke of a parent engagement survey which will be utilized as a way to find out how to get more participation from parents. Some questions being considered: "What do you want for your child, yourself, your family? Is there any specific reason you cannot attend meetings? Is there a better date/time to attend meetings." - A. Executive Director's Report: Ms. Kossick spoke of jobs.sacramentoworks.com. Ms. Kossick distributed information on the site and urged all board members to tell their friends and family about this great site. There is a lot of great free information available on the web site. Ms. Kossick asked for feedback on parents that went to the web site.
- B. Head Start Deputy Director's Report: Ms. Denise Lee reported that the Agency has applied for a waiver on some of the non-federal share matching. For every dollar spent, the Agency has to have a non-federal share match. WCIC and San Juan have found themselves short of expectations for their non-federal match; these programs thought some of the match could be offset with parent participation. The waiver, requesting \$800,000 relief, was sent last week. Staff is encouraged delegates to get as much non-federal match done as possible. The state budget continues to be tight. The biggest issues will be if the government takes the full day preschool services and move to something else. When parents volunteer in the classroom, it is valued at \$24.00 per hour.

Ms. Taylor stated that the TB clinic was great but she wanted more notice. Ms. Lee replied that the clinic is rotated around the various centers every quarter. June 7 is an Advocacy Day at the Sheraton Grand Hotel. There will be a meeting in the morning. Ms. Lisa Carr has the information in her office; there is a \$30.00 fee for those that participate.

- Brenda Campos: Grantee Program Support Services: Ms. Campos reported that the next Health Services Advisory Committee is scheduled for October 24, 5:30 p.m., in the Sequoia Room. In the grantee operated program, a center at Grant Skills Center was leased. However, the enrollment has increased and the school district asked SETA to vacate the Grant Skills Center. The North Avenue center will open the first of June. The Program Information Report (PIR) is a report submitted to the Office of Head Start; this report will be completed and turned in early.
- Lisa Carr, Parent/Family Support Unit: Ms. Carr reported that a review was done of the Parent Conference. The next meeting is in October. Staff are doing group enrollments for the North Avenue center so it is expected there will be full enrollment. The Agency is doing county-wide recruitment for Head Start and Early Head Start. There will be bus placards which will run in 200 buses and 15 bus shelters.
- Karen Gonzales: Child Development and Education Service: Ms. Gonzales reported that children are going through the last assessment period of the year and parents were urged to talk with the teachers. SETA Operated Program

Family Support Services:

With summer upon us, the main thing all Family Service Staff are working on is enrolling families. Staff is busy recruiting and enrolling eligible children into our Head Start and Early Head Start classrooms. Staff at the State funded programs are also busy recertifying that families are still eligible to attend full-day programs.

On June 30, a Daddy and Me day was held at the Crocker Museum. Families were able to attend the Crocker Museum, with tickets donated by the museum. Over 40 fathers and their children attended this educational and fun event.

Program Operations:

Child Development staff have attended some wonderful trainings this month. Preschool staff participated in CLASS-De-constructed: Emotional Support. This training supports teacher's skills in providing positive climates, regard for student's perspectives, and teacher sensitivity. These skills help develop relationships which are essential to effective classrooms. Our Early Head Start staff participated in Talking with Toddlers. This training looked at the exciting language and literacy milestones children make in their toddler years and how teachers can promote these skills. Feedback from teachers indicated that these professional development opportunities were well received.

Many children are getting ready to move on to kindergarten. Teaching staff are meeting with parents to discuss the progress made throughout the year as well as how they can support their child through this transition. Staff is excited to see these bright young minds take on their next adventure.

Elk Grove Unified School District

Enrollment

Elk Grove Unified School District Head Start has fourteen classes on a traditional calendar and seven classes on a modified traditional calendar. The seven classes on a modified traditional calendar remained open until June 19. Average daily attendance in the seven classes was 87%.

Disabilities Services and Mental Health Services Update

The program educators and clerks have worked closely with the PreK social worker, Florence Oneto

and with the PreK psychologist, Teresa Gannon to place students with an active IEP into the Head Start program. The program served 55 students (13%), with active IEPs during the 2011-2012 school year. This number exceeds the 10% minimum required by Head Start.

Recruitment

An internal office calendar with registration dates for January through July has been created to ensure full enrollment and create a waiting list to fill vacancies if families move between registration and the first day of school in August.

Region I, which includes John Reith Elementary, Herman Leimbach Elementary, Charles Mack Elementary, Union House Elementary and Prairie Elementary Schools, has registered 373 families between January 1 and June 30. Region II, which includes Florin Elementary, Isabelle Jackson Elementary, William Daylor High, and Samuel Kennedy Elementary Schools, has registered 251 families. Region III, which includes Maeola Beitzel Elementary, David Reese Elementary, Franklin Elementary, Florence Markofer Elementary, and James McKee Elementary Schools, has registered 287 families.

Sacramento City Unified School District

Closed - no report for this month.

San Juan Unified School District

Education Services Update:

Committees were formed so teachers could be invited to help plan for the staff calendar, the parent calendar and the Professional Development plan for the 2012-2013 school year. The DRDP data, Head Start Three-Year Goals, general mandates and teacher survey results were considered as the draft for our 2012-2013 Professional Development Plan was created. A comprehensive draft is in circulation for feedback and suggestions, before the new plan is approved.

Disabilities Services Update:

As teachers turned in their end-of-the-year paperwork, which included cumulative files and IEPs, the Disabilities Specialist combined the teacher IEPs with the file IEPs and checked the dates for aged-out students or continuing students. The IEPs for the older students were then, documented, boxed and prepared for storage. The continuing student IEPs were filed and readied for disbursement back to the teachers in August. Also during this time, the IEPs have been checked several times to complete and rectify the numbers for the PIR report. As students with IEPs register for the upcoming school year, IEPs are put into Child Plus and placed in a confidential red folder and filed into the class file.

Mental Health Services Update:

The Mental Health Therapist supporting screening process for the 2012/13 school year and addressing Red Flag mental health concerns that include providing families with early intervention resources as well as school readiness preparation skills.

Nutrition Services Update:

After completing the survey request by U.C. Berkeley's Center for Weight and Health, it became apparent that the implementation of Nutritional Best Practices is occurring. As a result, the following practices have been instituted:

- Non-flavored, fat free milk is served; 1% low fat is served for breakfast and lunch (cafeteria)
- Juice is not an option for snack, only breakfast (cafeteria)
- Staff are trained to decline sugar sweetened "extra's" provided by the cafeteria
- Water is available at all times.

Health Services Update:

Health is screening three days a week in the Centralized Screening Room. Health is preparing for the 2012-2013 school year and is reviewing all reports and data entered in Child Plus for the PIR report.

Family and Community Partnerships Update:

Policy Committee is not holding a meeting in June.

Transition Services Update:

There are no Transition Services provided in June since school ended June 1, 2012.

Program Support/Staff Training Update:

There was no training for teachers in June since school ended June 1, 2012.

Fiscal Update:

Both programs are expected to be overspent by approximately 3%.

The requested waiver for the 2011-12 reduction of in-kind is still in the hands of the Office of Head Start.

At this time plans are to cover the entire 25% match required by the Head Start Performance Standards.

Early Head Start:

June marks the month when children enrolled in the combination option end their classroom experiences and begin home visits throughout the summer. This is especially valuable to families whose children will be entering preschool in August, 2012. This gives them individualized attention to facilitate this exciting transition. Enrollment is continuing along with entering information for the annual Program Information Report (PIR).

Twin Rivers Unified School District

Closed - No report for this month.

<u>WCIC</u>

WCIC/Playmate Head Start Programs 2012 Graduation Class consisted of 71 graduates. WCIC's 2011-2012 School Year ended Monday, June 4, 2012. However, the Full-Day Class Summer Program began on Wednesday, June 6, 2012. The summer program's teaching team members are focusing on the following Readiness Skills: Enthusiasm Towards Learning, Solid Oral-Language Skills, Ability To Listen, Desire To Be Independent, Ability To Play Well With Others, Strong Fine Motor Skills, and Basic Letter and Number Recognition.

WCIC/Playmate Head Start Programs FY' 2012-13 Delegate Agreement Documents were submitted to SETA Contracts Unit as required.
