Ms. Kossick recognized Mr. King for his leadership and outstanding guidance.

C. Approval of Funding Extension Recommendations for the Workforce Innovation and Opportunity Act (WIOA), Title I, Youth Program, for Program Year 2020-2021

Ms. Terri Carpenter reviewed the funding recommendations and reported that the Agency received an increase in funding for the youth program. The Department of Labor (DOL) has given local workforce boards authority to allow providers to

continue paying youth stipends for distance learning; staff have been working with the providers to ensure enrollment numbers will be met. Ms. Carpenter stated that this is the same funding level that was recommended last year. There will be \$50,000 set aside for Youth Committee initiatives; another \$45,000 will be set aside for whatever wage increase that will take effect in January. The total youth funding recommendation is \$2,300,892 with a stipulation that additional increases be distributed according to year-end reviews. In addition, \$50,000 will be set aside specifically for COVID related-issues.

Moved/Gordon, second/Clawson, to approve the staff funding extension recommendation for the WIOA Title I, Youth Program, PY 2020-2021. Approve with the stipulation that all funding recommendations are contingent upon satisfactory year-end program performance reviews and final WIOA funding allocation.

Mr. Roy Kim stated that each year the board takes action on how the funds are allocated throughout the job center system. The adult funds were received with a small increase of approximately \$53,000. The funds will be allocated proportionately.

E. Discussion on the Role of the Sacramento Works Board

Mr. King reported that the Executive Committee talked about the variety of information to share with the board and then try to engage the board in conversation. Three speakers that will present information:

- Kathy Kossick: will provide a status report on Sacramento Works, what has happened over the past months.
- Amanda Blackwood: will join the meeting around 9 a.m. as head of the Metro Chamber and will share impacts to businesses in our region.
- Cara Welch from EDD: will expand on the unemployment impact and what the department is expecting in the future.

Ms. Kossick stated that from the day staff have been sheltering in place, Mr. Kim and his staff have continued to work remotely as well as in the office. Of the 12 job centers, four have physically been seeing people by appointment only; the remaining have been connecting virtually to assist customers. To date, the Agency has received \$90,000 for emergency support services to customers and \$300,000 of national dislocated worker funding. With the Heroes Act, it is expected that \$2.4 billion of the proposed \$3 trillion would be geared toward dislocated workers and youth.

Mr. Roy Kim reviewed the dislocated worker report. The City of Sacramento received CARES funds and the County of Sacramento received even more. Staff have been involved in a number of webinars with city officials sharing our system as a resource. SETA staff are assisting people navigate the various ways to get assistance. SETA is partnering with restaurants and small businesses to provide OJT to help bring back their laid off workforce. Staff is also talking to the Community Action Board about supplemental CSBG funds for safety net programs. We will be going through some type of procurement for those funds. It is uncertain as to how it will translate at the local level.

Ms. Cara Welch reviewed the April report with 14.2% unemployment rate up from 4.9% in March. Historically, 14.2% has been the highest in Sacramento. Ten out of 11 industries have experienced unemployment increases. The impact of COVID 19 has been very apparent. There is a projection that there will be similar numbers in May.

Ms. Welch stated that EDD has been asked to give an update on unemployment insurance claims filed. For the week of May 9, 11,000 UI claims were filed; 80% of people report that they expect to be recalled to their jobs.

Ms. Blackwood joined the meeting at 9:08 a.m.

Ms. Blackwood stated that two years ago, the Brookings Institute talked about what made our recovery from the 2008 recession so difficult. A webinar will be held with Prosperity Partners of the Metro Chamber of Commerce, the Greater Sacramento Economic Council, SACOG and Valley Vision. They will partner with the Sacramento Chamber to dig into the work that's been done over the last two years on how we make ourselves more resilient moving forward.

Ms. Blackwood stated that businesses will need to accept that things are going to change. Many businesses have pivoted functionality to become web-based businesses. Financial stability is a huge issue for businesses; most do not have large cash cushions. Ms. Blackwood expects it to be a two-year recovery process; a lot of changes will take place.

Mr. King thinks the board should consider a different area of focus. We will never go back to the 'normal' that we saw at the beginning of the year. A majority of the SMUD workforce went to working remotely; they are looking at having only 20-30% of staff return to work at any time. Sacramento Works should look at changes that will come from this pandemic, i.e., retraining employees, outgrowth from the pandemic, etc.

Ms. Blackwood stated that we will have to rapidly reskill a large number of people that will no longer be able to work in their chosen occupation.

Mr. King stated that there may be some benefit looking at an ad hoc group to look at guiding recovery after the pandemic.

Mr. Wylie stated that his question for the board is are you willing to step up? Often this meeting goes 1 ½ hours; is the board willing to see meetings go to two hours as the more standard meeting time? Perhaps consider having monthly meetings? Mr. Wylie sees committees as an important way to do business. While he is no longer chair of the Employer Outreach Committee, that committee is important to understand how to coach and mentor employers. The EOC collaborates with the Metro Chamber of Commerce, Valley Vision, and other organizations better able to bring to the business community the combined objectives. Is there a strategic planning committee to assist in getting grants? He will need to meet with the new Executive Committee to talk about the various things the board needs. He will be asking board members to participate in the committees and the meetings that will assist in guiding staff.

The unemployment rate in the Sacramento--Roseville--Arden-Arcade MSA was 14.2 percent in April 2020, up from a revised 4.8 percent in March 2020, and above the year-ago estimate of 3.4 percent. This compares with an unadjusted unemployment rate of 16.1 percent for California and 14.4 percent for the nation during the same period. The unemployment rate was 15.4 percent in El Dorado County, 13.3 percent in Placer County, 14.7 percent in Sacramento County, and 11.9 percent in Yolo County.

Between March 2020 and April 2020, combined employment in the counties of El Dorado, Placer, Sacramento, and Yolo decreased by 151,000 to total 875,600 jobs.

- Leisure and hospitality (down 52,000 jobs) posted the largest month-over employment decline. Accommodation and food services (down 45,000 jobs) fell sharply from March to April. Arts, entertainment, and recreation was down 7,000 jobs.
- Trade, transportation, and utilities reported a month-over decline of 29,700 jobs. Retail trade lost 21,700 jobs. Transportation, warehousing, and utilities cut back 4,600 jobs. Wholesale trade employment reduced by 3,400 jobs.
- Education and health services fell by 25,500 jobs. Healthcare and social assistance (down 24,100 jobs) accounted for 94.5 percent of the decline.
- Mining and logging, which remained unchanged from March to April, was the only major industry sector to report no job losses.

Between April 2019 and April 2020, total jobs in the region decreased by 145,700, or 14.3 percent.

- Leisure and hospitality led year-over decline for the region, shedding 57,800 jobs. Accommodation and food services (down 48,400 jobs) was responsible for the majority of the job reductions. Arts, entertainment, and recreation lost 9,400 jobs.
- Trade, transportation, and utilities decreased by 25,700 jobs. Retail trade was down 20,700 jobs. Wholesale trade dropped 3,100 jobs, and transportation, warehousing, and utilities cut back 1,900 jobs.
- Education and health services fell by 23,900 jobs since last April. Education and health services (down 22,400 jobs) accounted for 93.7 percent of the job descend.
- Financial activities (up 1,300 jobs) was the only industry to report job growth from last April. The job gains were concentrated in finance and insurance, which added 1,300 jobs.


