CALL TO ORDER ROLL CALL

Mr. Ellis called the meeting to order at 3:00 p.m. The roll was called; quorum was established.

I. ACTION/DISCUSSION ITEMS:

A. Approval of Minutes of the April 9, 2024 Regular Meeting

There were no changes or questions.

Ms. Hutchinson arrived and was seated at 3:01 p.m.

II. INFORMATION ITEMS:

- A. Special Guest New SETA Executive Director Ms. Anita Maldonado
 - Mr. Ellis introduced the new SETA Executive Director, Ms. Anita Maldonado, and highlighted her background. Ms. Maldonado took the opportunity to introduce herself. She additionally advised that SETA has been engaging in strategic planning with Dalberg Consulting to develop the Agency's first-ever strategic plan. Ms. Maldonado also mentioned that she was looking forward to the All Staff meeting on August 9, 2024.
- B. Employer Meetings/e-Newsletter

Mr. Walker gave the committee members a printout of the e-newsletter and a report on it. He mentioned that the Northern California Contract Center Association, featured in the e-newsletter was a long-standing partner of SETA for 15 years. We recently held a job fair for the State of California with over 1,200 individuals registering; 400 individuals attended seeking employment, and SETA was pleased with the turnout.

C. KPI Monitoring

Mr. Walker reviewed the Key Performance Indicator Report (KPI) provided in the handout. He shared that the New Employer Registration number which previously went down was due to this information being considered confidential and is therefore provided in the aggregate by the Employment Development Department, Labor/Marketing Information Division He advised that the numbers were provided to him upon request and on a monthly basis, which resulted in an increase from 49% to 772% on the report.

D. Seminars Workgroup

Mr. Ellis reviewed the information provided in the handout, which included the dates for prospective seminars from September 2024 to October 2025 and outlined the associated planning process. He invited any interested Committee members to join the seminars workgroup, which currently has only two members: Mr. Hoke and himself.

E. Promoting Employer Services Workgroup

Mr. Ellis advised that at the January 2024 meeting, the Employer Outreach Committee (EOC) endorsed 22 items on EOC priorities to promote employer services. He requested Mr. Walker and his staff to review the progress made and report at the next EOC meeting in October.

Ms. Devine shared out on the social media campaign. She advised that the current Facebook account has 17,000 followers, a 4,000 annual increase since January 2024.

Mr. Ellis invited any interested Committee members to join the Promoting Employer Services workgroup.

F. 2024 Action Plan and Annual Program

The approved 2024 Action Plan and Annual Program were provided in a handout and briefly reviewed.

Ms. Hutchinson will discuss "PAID" sponsorship opportunities for topical seminars after the meeting.

G. EOC Housekeeping

Mr. Ellis was pleased to report that Ms. Hutchinson, despite leaving the Sacramento Works, Inc. Board, agreed to continue to serve on the EOC. He encouraged members of the Committee to recruit and refer prospective candidates to him.

Ms. Maldonado advised that SETA is in the process of hiring a Public Information Officer to increase its external presence in the community.

Mr. Kim advised that SETA recently held a successful State Job Fair, in which forty-three state departments participated.

The strategic planning consultant from Dalberg Consulting will provide updates on the SETA strategic planning process at the next Sacramento Works Inc. Board meeting in September.

Mr. Kim advised that at the last meeting of the SETA Governing Board, the funding recommendation to extend job centers' contracts for PY 2024-2025 was approved. He was pleased to announce that the allocations had increased by almost \$1 million.

Mr. Kim encouraged the members to refer any private business representatives of companies hiring in the Sacramento area to apply and join the Sacramento Works Inc. Board.

Mr. Walker advised that SETA is working with Capitol Impact by providing a talent pipeline management process and assisting employers directly with recruitment.
