Ms. Perez-Lima introduced herself, shared some background information, and elaborated why she wanted to join the Committee.

III. DISCUSSION/ACTION: Consideration of Sponsorships – Construction Industry Education Foundation (CIEF) – Design Build Competition and Sacramento Regional Youth Career Fest

Ms. Mechals presented on the item. She advised that the 2023-2024 Youth Program budget includes \$50,000 that can be used to support the hiring of Youth Voice members, community outreach events, youth workshops, job fairs, and event sponsorships.

Ms. Jennifer Poff, a representative from the North State Building Industry Association, shared that the Construction Industry Education Foundation (CIEF) is a program that aims to raise awareness about career opportunities in the construction industry among high-school students. CIEF provides hands-on experience in the construction process, similar to the North State Building Industry Foundation program. The CIEF Design Build Competition, which will take place on May 1-2, 2024, will challenge participating teams to design, plan, and construct a 96 sq. ft. structure, such as a greenhouse, playhouse, or micro-home, that meets specific criteria established by industry professionals. Sponsors will fund the event costs, including safety gear and Occupational Safety and Health Administration training, building materials, scholarships, and free admission for all students. Ms. Poff also mentioned that CIEF focuses mainly on commercial buildings, whereas NSBIF focuses more on residential buildings. Students can sign up for the competition through the Career Technical Education program at their school.

Moved/Perez, second/Reynolds, to approve allocation of a total of \$2,000 in Youth Committee Initiative funds – 1) \$1,000 for a bronze sponsorship of the CIEF Design Build Competition and 2) \$1,000 for the Sacramento Regional youth Career Fest (SRYCF). The events will be staffed by the SETA WIOA Youth Providers, Youth Voice Committee Members, and SETA/Sacramento Works staff providing career pathway information and work readiness resources to event participants.

Ms. Martinez reviewed the WIOA Youth Program PY 2023-2024 Performance Summary Report provided in the agenda packet. The California Indian Manpower Consortium will no longer provide the WIOA Youth Program and funds will be re-allocated.

V. INFORMATION: North State Building Industry Association, Out-of-School WIOA Youth Program Presentation and Tour
The North State Building Industry Association team of staff and participants provided information on the community services and programs available for students, including virtual reality projection training for those aged 18-24.

VI. OTHER REPORTS: Youth Voice Committee Update
Ms. Perez-Lima stated that she is currently working at the Mark Sanders Job Center and has been observing the work of one of the Youth Specialists. Additionally, she was excited to report that a new mental health location run by youth will be opening in Sacramento by the Greater Sacramento Urban League, which she has been a part of, in partnership with Allco. Soon, the site will serve as an *allcove* youth drop-in center, designed with, by, and for youth ages 12 to 25 to increase accessibility to affordable mental health and wellness services. In partnership with Sacramento County and Stanford University, GSUL will facilitate as the lead organization for *allcove*'s first Sacramento-based location to help meet the evolving needs of young people in the region.

Mr. Rocha-Rosario introduced himself and informed us that he works with youth voice representatives. He conducts various workshops to create awareness about the different youth programs available. Additionally, the youth voice representatives have been provided an opportunity to attend the 2024 California Workforce Association Summit in Long Beach, California.

Another improvement is that the youth participants remain engaged in the program until they reach their individual training and employment goals.

Ms. Mechals added that SETA secured The High Road Training Partnership funding, which will help WIOA Out-of-School youth that have more advanced employment and training goals to increase program completion rates and address participants' financial needs.

Ms. Mosley inquired whether EGUSD offered driver's education training. EGUSD clarified that driver's education is not currently provided, but referrals are available for those that have a need.

B. Youth Voice Presentation – Youth Committee Members

Mr. Rocha-Rosario presented on SETA's Youth Voice Initiative. Ms. Vega, Ms. Marquez, Ms. Perez-Lima, Mr. Horta, and Ms. Mosley shared their journey and experience as youth voice representatives at SETA. The presentation is attached.

Ms. Mechals thanked Ms. Reynolds for meeting with youth voice members and collaborating on revamping the Youth Program Flyer.

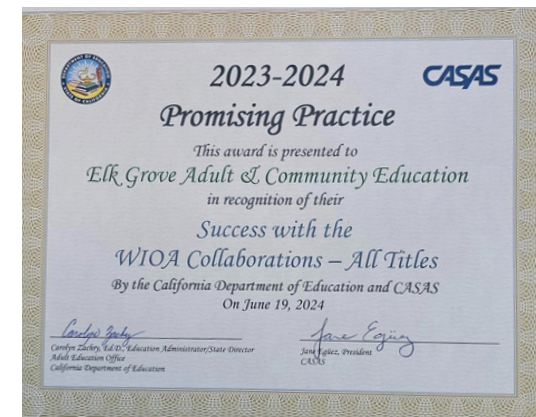

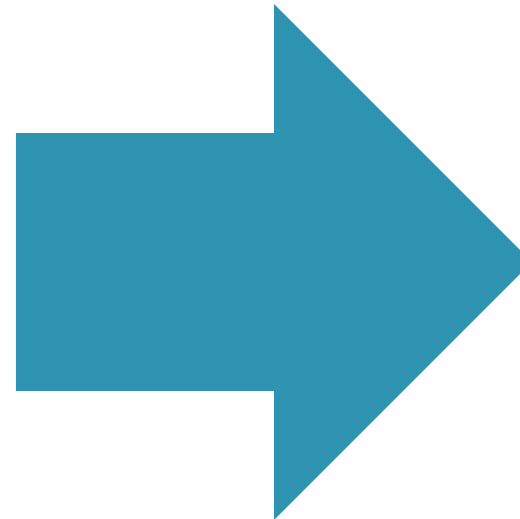

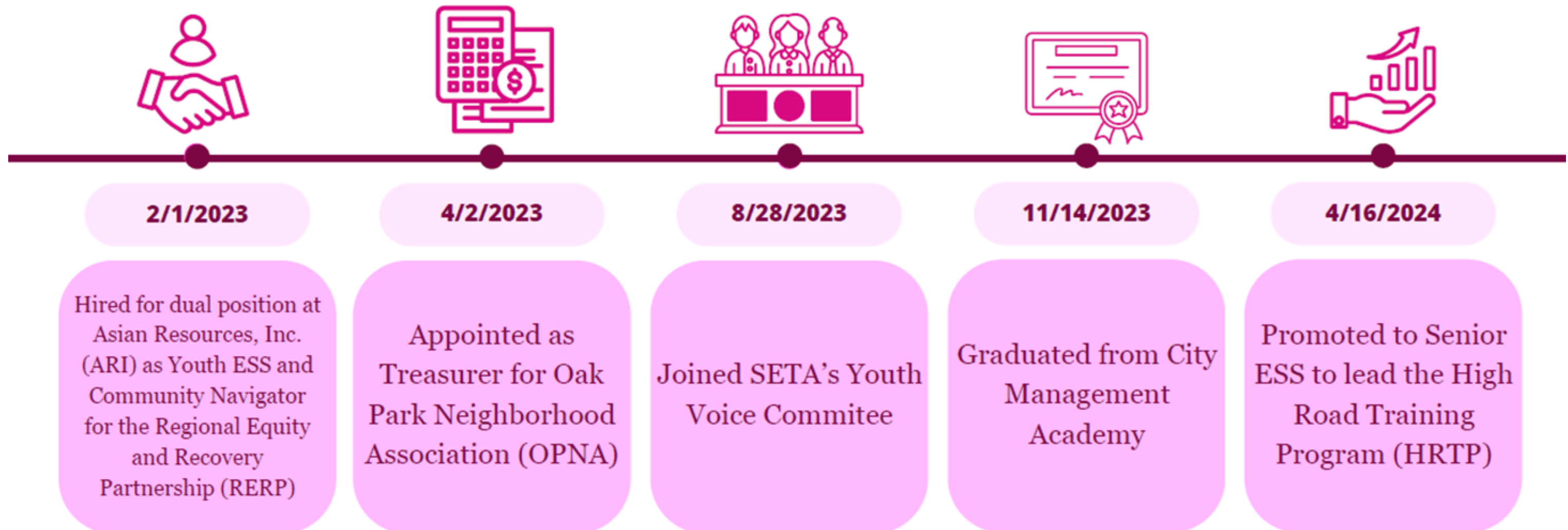

My Experience with Youth Voice:

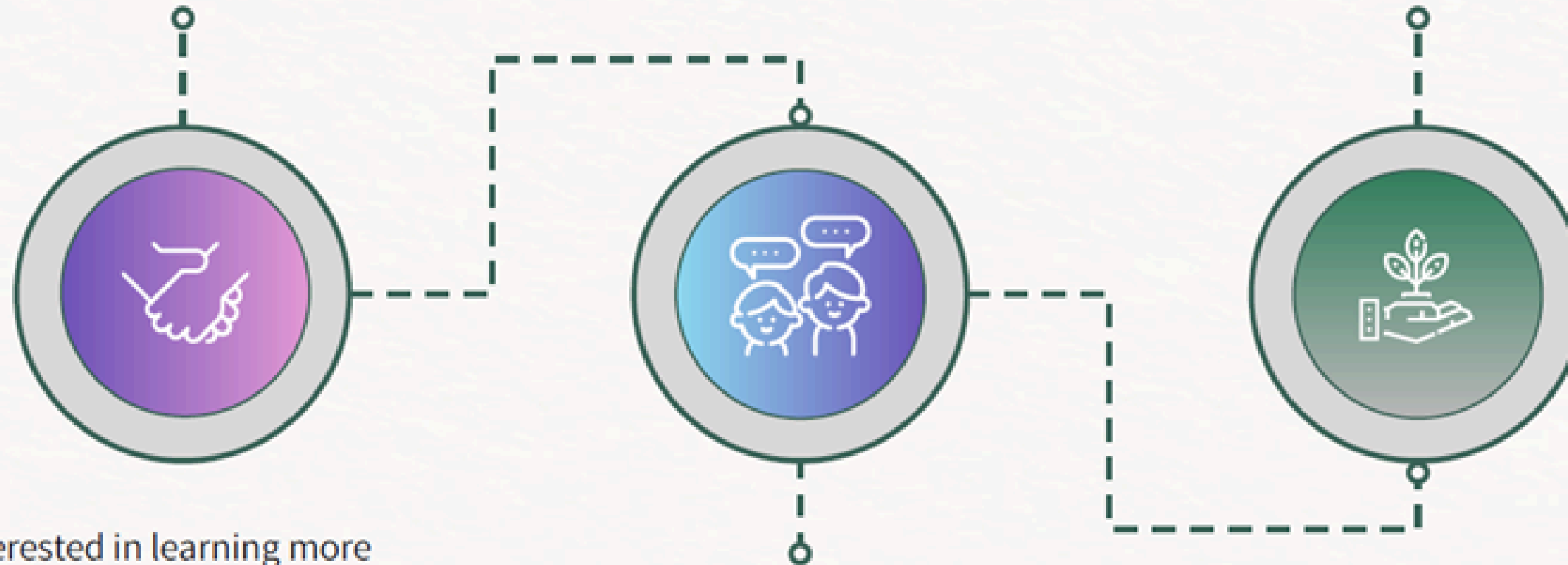

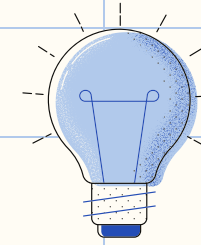
WHY YOUTH VOICE?

That's when I was first introduced to SETA. I was working with the employment specialist at CD going over my options, nothing appealed to me until he showed me the youth voices flyer.

Why Youth Voice?

I have always found advocacy important. I tend to find myself defending and helping people wherever I go, even if I don't know them. Youth Voices called to me because not only have I been struggling with employment but so have many others around me. I wanted to learn as much about the work force as possible to help myself and others, so I applied.

My Experience at S.E.T.A

I have learned how to utilize my greatest skills to my advantage. Most importantly I have acknowledged skills that require improvement and how to do so. During Youth Voice, I had the opportunity to do things I never envisioned myself doing, such as attending board meetings and conferences. My time at SETA has exposed me to an entire field of possibilities and opportunities that were not on my radar prior.

Future Goals

Currently my top goals are to get my drivers license and go to college.
